To Whom It May Concern:

Thank you for your interest in helping Tony and Steve Sakac. Tony's quadriplegic condition **requires** a new set of specially-designed shoes and leg braces. More importantly, Tony **needs** a properly-fitting wheelchair. (The one he is using was designed for another patient and does not fit correctly.)

Your kind contribution will help pay for these much-needed devices which are long over-due. Their cost is **\$14,000**. Kessler Institute for Rehabilitation (in Saddlebrook, NJ) on May 31, 2007, gave Tony a prescription for new shoes, braces, and wheelchair. Government Social Services will not cover the cost of these items, given the state of Tony's unique medical condition. That is why it is **more urgent** that concerned individuals and church communities offer private assistance to Tony.

Please know that I have been the friend of Steve and Tony Sakac for several years now. From time to time Steve and Tony have visited our community of St. Michael the Archangel Orthodox Church in Wilmington, Delaware, for Divine Liturgy. I can bear witness that I know Tony's father Steve (Istvan) to be a man of strong courage and great joy. He sacrifices tremendously to care for his son. He constantly seeks improvement and healing for Tony. May the Lord strengthen both of them.

I hope and pray that the Lord will inspire as many people as possible to do all that they can to assist and support Tony in his medical rehabilitation.
